### ELIGIBILITY

1. Exhibitors must have fed Farmers Cooperative and/or ADM Alliance Nutrition products for at least 60 days prior to show.
2. Eligibility is based on livestock projects in market classes (steers, lambs, goats, hogs) Jackpot and prospect shows do not qualify for the premium program.
3. The patron refund is limited to one animal per youth per show year.
4. The account in which the feed is purchased throughout the year must be in good standing.
5. A color picture (winning-day photo preferred) is required with the application; any quality 35mm or digital photo is acceptable. (We prefer *Digital photos, or digitized copies, may be emailed to amy.stephens@farmerscoop.com.*) Please make sure to include your name and account number in the email.)
