INSTRUCTIONS FOR FEEDING

MoorMan's 646 Block is formulated for grazing cattle on pasture or range receiving little or no grain.

When starting to feed, remove salt and feed MoorMan's 646 Block. Feed continuously near the cattle's source of water, protected from rain.

Put out one block for each 15 to 20 head of cattle. Recommended consumption is 0.25 lb (1/4 lb) to 0.5 lb (1/2 lb) per 100 lb of body weight per month.

If consumption is more than recommended, feed salt in addition to the blocks. If consumption is less than recommended, make sure no other source of salt is available, feed in more places or change to MoorMan's 646 Mineral.

CAUTION: Consumption of this product by sheep and goats may result in copper toxicity.

NOTE: To be fed as the sole source of selenium. Beef Cattle should not receive more than 3 mg selenium.

*This product is not intended to be a significant source of potassium.
